As a result of browsing the website and completing the web forms, the user accepts that the personal data that they have provided, or which may be provided in the future through this service, is subject to being processed in the personal data files of event organisers, including the collection of access details and the use of cookies and functions provided by third parties.

Purpose of data processing, legal basis and information recipients

The data is used to:

- Allow the website to function and to provide access to areas intended for registered users.

- Pre-register the attendee in the Spanish Host-In APP and (if you consents to it) show their name, surname, company and position to the rest of the attendees, so that they can arrange meetings (this data will be shown to other registered users)
- Send commercial communications on behalf of HOTUSA and CBRE about their respective products and services, similar to those that you have contracted previously (Spanish Host-In investment forum).
- Send commercial communications about events, promotions, prize draws, and other commercial communications about HOTUSA and CBRE products, services and content.
- Prepare web analyses and statistics.
- Include functions provided by third parties (Google Maps, etc.).

Web browsing and access to areas for registered users

- Purpose: the necessary data is processed to provide online services, including registering IP addresses, visited pages and access data, as well as information about the user terminal. The data is also processed for security and web improvement purposes.
- Legitimacy: data processing is necessary to provide online services; consent, given through using the website.
- Recipients and transfers: HOTUSA companies and establishments.

The submission of all data required to register as a user is compulsory unless otherwise specified on the registration form; HOTUSA and CBRE may reject the registration of the interested party if this data is not provided.

Using the web forms to register for the Event

- Recipients and transfers: Service providers and third-party companies when necessary, so that HOTUSA and CBRE REAL ESTATE can fulfil, develop, manage and implement the contractual relationship established between you and them.

Sending commercial communications on behalf of HOTUSA and CBRE about products or services similar to those contracted

- Purpose: To send commercial communications on behalf of HOTUSA and CBRE about their respective products and services, similar to those that you have previously contracted.
- Legitimacy: Legitimate interest resulting from a previous contractual relationship.
- Recipients and transfers: Service providers and third-party companies when necessary, so that HOTUSA and CBRE REAL ESTATE can fulfil, develop, manage and implement the contractual relationship established between you and them.

Sending HOTUSA and CBRE commercial communications

- Purpose: To send commercial communications about events, promotions, prize draws, and other commercial communications about HOTUSA and CBRE products, services and content.
- Legitimacy: Consent.
- Recipients and transfers: Service providers and third-party companies when necessary, so that HOTUSA and CBRE REAL ESTATE can fulfil, develop, manage and implement the contractual relationship established between you and them.

Web Analytics

- Purpose: to know how the website is searched for, accessed and used by the public. It may involve the collection of personal data such as IP address, connection location, information about browsing software or hardware, etc.
- Legitimacy: consent, given by using the website.
- Recipients and transfers: HOTUSA companies and establishments.

Functions provided by third parties

- Purpose: to include functions provided by third parties, such as maps, analytics, social media buttons, widgets, etc.
- Legitimacy: consent, given by using the website.
- Recipients and transfers: Third-party functions establish a direct link between the user's browser and third-party Internet domains, allowing the download and execution of the function, including from pages outside the European Economic Area.

This website includes Google Inc. functions, such as Google Analytics and Google Maps. By using this website, the user authorises the processing of their data by

Data veracity

Rights of access, rectification, erasure, opposition and others

They also have the right to request: the portability of their data, the revocation of the consent given when applicable, and the limitation of data processing.

Cookies policy
